This is an installation of three videos inspired by our Environmental Risk Longitudinal Twin Study (E-risk) in collaboration with artist Jordan Baseman. The show opened at the Monash University Museum of Art and Design to an audience of over 900 in February, 2007, and shows at the Newcastle Policy Ethics & Life Sciences Center were viewed by more

than 700 people in March-April 2007; and 50 viewers attended the invitation-only show at the Wellcome Trust Museum of Medicine in London in May, 2007. "Laws of Variation" films a very bloody multiple-birth delivery, with voiceover of Terrie Moffitt discussing the joys and traumas of human variation. "Tape1 Tape2" presents a mother of MZ twins explaining to one of our research workers the reasons why she adores one daughter and dislikes the other. "Nature's great experiment" narrates a research workers' view of the science of behavioural genetics, and describes her day-to-day experiences with families, some of whom harm or neglect their twins. The art was funded by the Wellcome Trust. The website has been visited by more than 30,000 viewers each year since 2007. In 2010 the films are screened in lecture theatres and galleries in Belfast, Dundee, Aberdeen, Hull, and Bury St. Edmunds, as part of the Wellcome Trust "identity" series.

IN January 2013, this paper was again in the news, as result of a challenge by Rogeberg:

Biosketch, 2013

When it comes to understanding antisocial and criminal behaviors, Terrie E. Moffitt, one of the leading voices in psychological science, takes the long view. In addition to directing the Environmental-Risk Longitudinal Twin Study, which began in 1994 and follows 1,100 British twins and their families, she is Associate Director of the Dunedin Multidisciplinary Health and Development Study in New Zealand, another ongoing longitudinal study that started in 1972. Through these studies, Moffitt has been able to link adult antisocial outcomes to their childhood origins. Her generative dual taxonomy of antisocial and criminal behavior divides those who exhibit these behaviors into a “life-course persistent” group, whose early-life antisocial behaviors persist throughout adulthood, and an “adolescence-limited” group, who eventually reform as they become adults. This trailblazing theory was one of the most influential in the field of criminology and has earned Moffitt a litany of awards, including the prestigious Stockholm Prize in Criminology in 2007. She has been a pioneer in other lines of her research as well: her team’s groundbreaking gene-environment interaction studies were the first in all mental health research to show how certain environmental conditions (in this case, maltreatment during childhood) can predict vulnerability to particular adult outcomes (antisocial and violent behavior) only in the presence of a specific genotype (a MAOA gene polymorphism). Gene-environment interaction has since become a vibrant and important field of study in behavioral research, with Moffitt still at the forefront, incorporating principles and techniques from neuroscientific research and observational epidemiology to try to elucidate the root causes of antisocial behavior and other mental disorders.
